

## **Training of Trainers (ToT) programs for the textile sector under the scheme PMKVY**

NITRA is happy to announce its first program of Training of Trainers under the scheme PMKVY. Govt. of India through the Ministry of Skill Development and Entrepreneurship (MSDE) has launched Pradhan Mantri Kaushal Vikas Yojana (PMKVY) recently. The objective of the Scheme is to encourage skill development for youth by providing monetary rewards for successful completion of approved training programs. This will boost the productivity of the country's workforce by enabling them to acquire high quality skill training.

We are glad to know that your mill has been affiliated as Training Provider with Textile Sector Skill Council (TSC), New Delhi. In this context, we wish to inform you that NITRA has been approved by TSC to conduct Training of Trainers (ToT) programs for spinning, weaving, knitting and chemical processing sectors.

It is a mandatory requirement for the mills to get their trainers trained and certified before commencing training in the mills.

### **Details of the ToT programme are as follows:**

Duration	:	3 days
Dates	:	2 <sup>nd</sup> November to 4 <sup>th</sup> November 2015
Venue	:	NITRA, Ghaziabad
Training Cost	:	Rs. 15,000/- per trainer (The training cost includes lunch and tea & snacks during the program)

The program is non-residential in nature. In addition to the training cost, mills will also have to bear expenses towards travel, stay and food of the trainers.

During the 3 day training program, the trainers will be apprised about the details of QPs developed by TSC, assessment criteria, the PMKVY scheme and the QPs of lead trainers developed by NSDC.

1. List and CV of trainers (as per attached format)
2. Fee of Rs. 15,000/- per trainer by DD/Cheque in favour of "Textile Sector Skill Council" payable at New Delhi.
